Both parties shall safeguard the use of and access of information to which the services provided or arranging for services shall not use or release any reports, data or other

information in accordance with the rules and regulations of VSP SYSTEMS and MSEC. Such information shall be used only to assure proper planning, coordination, monitoring and administration of performance under this agreement, and permit the transfer of records to another, for the purpose of continuing services, with appropriate approval from the authority concerned.

Service audit and program review functions shall be performed jointly when appropriate. Both parties mutually agree not to use the name of the other party in any public information without permission of the concerned party.

Review of this memorandum shall be made on or before 3 months before expiry at which time this agreement may be extended, modified or terminated.

VSP SYSTEMS and MSEC hereby agree to all of the above and enter into a joint agreement until such time that either party shall amend or review the said agreement in writing.
